More than 1,200 lb body weight .....	3 scoops per day

### Maintenance Period

Using the enclosed scoop, administer as follows after the initial period:

Less than 800 lb body weight .....	½ scoop per day
800 to 1,200 lb body weight .....	1 scoop per day
More than 1,200 lb body weight .....	1½ scoops per day
