INGREDIENT STATEMENT

Yeast Extract, Yeast Culture, Magnesium Proteinate, Dehydrated Alfalfa Meal, Ground Oats, Soybean Meal, Dried Cane Molasses, Hydrated Sodium Calcium Aluminosilicate, Zinc Proteinate, Fish Oil (Source of DHA and EPA), Natural and Artificial Flavors, Pyridoxine Hydrochloride (source of Vitamin B6), Folic Acid, Silicon Dioxide, Citric Acid (preservative), Vegetable Oil.

FEEDING DIRECTIONS

Enclosed scoop holds 3 oz.

For Maintenance: Feed 1 scoop (3 oz.) daily with regular grain ration, regardless of body weight.

For Performance: Horses should be fed Quietex™ Show Pellets starting at least 5-7 days prior to competition or event. Continue daily as needed during performance days.

Quietex™ Show Pellets can be fed alone or combined with Quietex™ Show Paste for added calming during competitions, shows or other stressful situations.

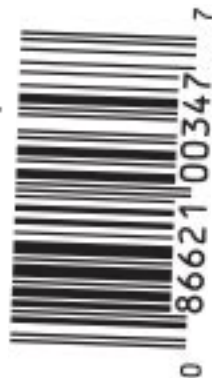
