Wipe Application: Application should be liberal for best results. For horse's face, **always** use a wipe using a piece of clean, absorbent cloth, toweling (Turkish) or sponge.

Getting spray into horse's eyes, nose or mouth. Wear rubber glove or mitt when applying wipe. Spray or wipe horse's entire body while brushing against the lay of the coat to ensure adequate coverage.

Apply every 14 days for fly control normal conditions for initial applications. As protection wears, reapply every 14-17 days. Reapply every 5 to 7 days for mosquito repellency. Reapply each time animal is washed thoroughly, particularly if with shampoo or soap.
