PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS AND DOMESTIC ANIMALS:

CAUTION: Harmful if absorbed through skin. Causes moderate eye irritation. Avoid contact with skin, eyes or clothing. GENERAL PRECAUTIONS & USE RESTRICTIONS:

- · Except when applying directly to horses, do not allow adults, children or pets to enter until sprays have dried.
- Except when applying to horses, do not apply this product in a way that will contact adults, children or pets, either directly or through drift.
- Remove or cover exposed food and drinking water before application.
- · Not for use on horses or foals intended for slaughter.

Apply by either soft cloth or fine spray mist. Only a light application is needed. Avoid using an excessive amount. Do not wet skin.

USE TO WIPE ON:

First, brush animal to remove dirt and dust. Moisten (but do not wet to the point of dripping) a soft cloth and rub over the hair. It is best to apply by rubbing against hair growth. Give special attention to legs, shoulders, shanks, neck and facial areas where flies are most often seen. After application, brush out thoroughly to bring out bright sheen on the coat. Repeat daily as needed.

USE AS A SPRAY:

WIPE N' SPRAY™ may be applied as a fine mist to stable area and over and around stabled horses for fast paralysis and kill of flies. Do not wet horse's skin or exceed two ounces per application.

STORAGE & DISPOSAL
